Circa Resort & Casino "Neon City Festival" Giveaway Official Rules

IMPORTANT! PLEASE CAREFULLY READ THESE GIVEAWAY RULES (hereinafter, the "Giveaway Rules") BEFORE ENTERING THE CIRCA RESORT & CASINO GIVEAWAY AS THESE RULES AFFECT YOUR LEGAL RIGHTS AND OBLIGATIONS.

Timing: The Giveaway shall start on September 20, 2024, at 12:01 a.m. Pacific Daylight Time (PDT), and all entries must be received by Circa Resort & Casino by 11:59 p.m. PDT on October 26, 2024 (hereinafter, the "Giveaway Period"). Circa Resort & Casino shall not be responsible for lost, late, or misdirected entries, server unavailability, computer, any other electronic malfunction, or human error relating to this Giveaway and/or the use of short-code. All references to time of day refer to Las Vegas, NV, time.

Winner Announcement: After a two (2) day verification period, allowing Circa Resort & Casino to randomly draw each Winner, the name of each Winner will be posted on Facebook®, X®, and Instagram® and each Winner will be notified via his/her email provided within the entry form on October 27, 2024.
