

River Cats Homestand Giveaway Official Rules Powered by Circa Resort & Casino

All references to time of day refer to Las Vegas, Nevada, time.

Odds of winning depend on the number of valid entries received. Remaining valid entries will carry over to future homestand random drawings held by the Sponsor for the remainder of the 2025 season during the Giveaway Period.
